Auditor Transition (Blended)



Introduction

This interactive course is designed for auditors who have knowledge of ISO 9001:2008 and wish to gain insight on how to interpret and audit the ISO 9001:2015 version of the standard.

Each clause of the standard is interpreted, followed by an explanation of an audit approach to the related clause. Particular emphasis is focused on strategic analysis and the context of the organisation, risk-based thinking and business process management.

Course outcomes:

- Audit ISO 9001:2015 requirements.
- Understand the fundamental changes from ISO 9001:2008.
- Appreciate the tools used to establish the context of the organisation.
- Assess risk management techniques, as used to apply risk-based thinking to a Quality Management System (QMS).
- Understand business process management and the use of the process approach in Quality Management Systems.

Who should attend:

- Auditors with existing knowledge of ISO 9001:2008 with a need to upgrade their skills and understanding to audit conformance with the requirements of ISO 9001:2015.
- Portfolios with responsibility for business assurance.
- Personnel responsible for internal or supplier audits

Benefits include:

- Material is developed by registered lead auditors serving on ISO/TC 176 committees, input to course design is also from literature review of observing member bodies.
- In-depth understanding of the new standard and how it should be audited.
- Broad view of how conformance may be achieved.
- Examples of tools and templates used for identification of context, risk and opportunity identification, action plans and response to requirements for QMS processes.
- Live online presentations with detailed course notes allow for the course to be taken from any location.
- The blended mode of delivery provides for webinar style live team feedback and live response from the facilitator.

The course structure ensures that knowledge of the requirements of the ISO 9001:2015 standard is delivered through an interactive learning system. Information is delivered in a series of pre-recorded videos and is supplemented by detailed written notes, pro-forma templates, registers and plans.

A facilitator interacts with the class online to assess teamwork, progress of candidates, and answer questions. The class is also able to collaborate online in a secure environment under the guidance of the facilitator.

The ISO 9001:2015 standard is not provided as part of the courseware and should therefore be obtained from your national standards body or from <u>www.iso.org</u>

Learning is reinforced with exercises and assessments and results in one of two certificates. A 70% aggregate or more will receive a certificate of successful completion.
